Program Expenses

VFU is primarily focused education of family, friends and veterans with empowerment based tools for healing and is **an all-volunteer organization**. Educational initiatives include a comprehensive website of information resources, attending and presenting at Yellow Ribbon Reintegration Events, and presentations to civilian and professional populations who work with veterans.
